PETITION

Petitioner, **VERTEX TOLLWAYS DEVT. INC.**, comes to this Honorable Board and most respectfully states:

- 1. Petitioner is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal place of business at 40 San Miguel Avenue, Mandaluyong City, where it may be served with notices and legal processes of the Honorable Board.
- 2. Petitioner is the Concessionaire in the Concession Agreement dated 08 July 2013 ("Concession Agreement") for the NAIA Expressway Project ("NAIAEx"). As Grantor, the Government of the Republic of the Philippines, through the Department of Public Works and Highways, authorized the Petitioner to: (1) finance, design, and construct Phase II of the NAIAEx; (2) finance and construct the at-grade works of the NAIAEx; and (3) operate and maintain the NAIAEx.
- 3. Section 12.1(a) of the Concession Agreement grants to the Petitioner the exclusive right and corresponding obligation to undertake the operation and maintenance of the NAIAEx and to exclusively impose and collect tolls therefrom during the Operation Period (as the term is defined in the Concession Agreement).

4. According to Section 13.1 of the Concession Agreement, during the Operation Period, the Concessionaire is authorized to impose and collect tolls from the users of the NAIAEx at the following rates, exclusive of value added tax:

Class I: Cars, Jeepneys, Pick- ups, Vans	PhP31.00	PhP40.00
Class II: Light trucks, Tourist/School and PUB Class I: above 7ft. in height except Class I exceeding 7ft. due to top load of recreational equipment such as bikes, surfboards, and the like, securely attached and not intended for commercial use	PhP62.00	PhP80.00
Class III: Heavy and Multi-Axled Trucks, Trailers	PhP93.00	PhP120.00

- 5. The foregoing initial toll rates ware provisionally approved by the Honorable Board on 08 February 2013. A copy of the Directors' Certificate dated 08 February 2013 is attached to this Petition as **Annex "A"**.
- 6. As provided in the Concession Agreement, the Petitioner shall collect the foregoing initial toll rates from motorists when the Petitioner opens the NAIAEx to the public, which is scheduled on 22 September 2016.
- 7. In relation to the Petitioner's authority to impose and collect toll, Section 2, Rule 4 of the 2013 Revised Rules of Procedure of the Toll Regulatory Board ("2013 Rules") provides the following requirements:

- a. Publication in full of the application or petition, the approved toll rates and the toll fee matrix at least once a week for three (3) consecutive weeks in a newspaper of general circulation; and
- b. Issuance of a Notice to Start Collection by the Honorable Board.
- 8. Conformably with the Concession Agreement and the 2013 Rules, Petitioner applies for the following from the Honorable Board:
 - a. A Notice to Start Collection authorizing the Petitioner to collect the following provisionally approved initial toll rates effective immediately:

b. An Order (i) finding the Petition sufficient in form and substance, and (ii) requiring the publication in full of this Petition, the approved toll rates and the toll fee matrix at least once a week for three (3) consecutive weeks in a newspaper of general circulation; and

c. After due proceedings and in accordance with Rule 4 of the 2013 Rules, an Order declaring the provisionally approved initial toll rate as final and authorizing the Petitioner to collect the same.

PRAYER

WHEREFORE, the foregoing premises considered, Petitioner most respectfully prays that the Honorable Board:

1. Immediately issue a Notice to Start Collection authorizing the Petitioner to collect the following provisionally approved initial toll rates effective immediately:

2. Issue an Order (i) finding the Petition sufficient in form and substance, and (ii) requiring the publication in full of this Petition, the approved toll rates and the toll fee matrix at least once a week for three (3) consecutive weeks in a newspaper of general circulation; and

3. After due proceedings and in accordance with Rule 4 of the 2013 Rules, issue an Order declaring the provisionally approved initial toll rates as final and authorizing the Petitioner to collect the same.

Other just and equitable reliefs are likewise prayed for.

WHEREAS, conformably with the Public-Private Partnership (PPP) Program of the government, the Department of Finance (DOF)-Privatization Group and the Department of Public Works and Highways (DPWH)- BOT Center, are spearheading the public bidding for the NAIA Expressway Project, Phase II (the "Project");

WHEREAS, the DPWH has obtained the approval of the Investment Coordinating Committee (ICC) of the National Economic and Development Authority (NEDA) to develop and implement the Project under the Build-Operate-Transfer Law, as amended;

WHEREAS, in line with the competitive public bidding to be conducted for the Project, the DOF-Privatization Group and the DPWH- BOT Center submitted to the Board for approval and eventual implementation the following Initial Authorized Toll Rate based on the Financial Model submitted to the Technical Staff, and assured the Board that they have validated the cost components of said rates and are consistent with the recommendations of the ICC and the approval of the NEDA Board. Thus:

WHEREAS, the Concessionaire to be formed by the winning bidder for the Project is expected to implement the Initial Authorized Rate after complying with the conditions for such implementation, as may be set out in the Toll Concession Agreement to be entered into by and between the Republic of the Philippines and the Concessionaire to be formed by the winning bidder for the Project;

WHEREAS, the proposed Initial Authorized Toll Rate was subjected to review and evaluation by the Technical Staff based on the Financial Model and information provided by the DOF-Privatization Group and the DPWH-BOT Center, whose findings were presented during the regular meeting of the Board held on 8 February 2013; and

WHEREAS, the Technical Staff has recommended to the Board the approval of the proposed Initial Authorized Rates subject to the certification by the DPWH of the Project Cost and Traffic Projections.

IN VIEW OF THE FOREGOING CONSIDERATIONS, the Board hereby unanimously adopts the following resolutions ---

RESOLVED, as it is hereby resolved, that the following Initial Authorized Toll Rates for the NAIA Expressway Phase II Project (the "Project") submitted to the Board by the DOF-Privatization Group, the PPP Center, and the DPWH-BOT Center, be provisionally approved subject to the certification by the DPWH of the Project Cost and the Traffic Projections. Thus:
